

## General Information and Instructions

Morning Garden offers parents and children an introductory experience with Waldorf education. We start by offering a soft, gentle space with play areas and all natural toys. The Parent-Child leader, using rhythm and consistency, guides children and parents through the morning. Morning Garden includes outdoor play, circle time with songs and rhymes, creative play, snack and story time. Meaningful work and activity are offered to parents and children as a way of nurturing the child's imitative skills. The Parent-Child program also provides a warm and friendly atmosphere for parents to share ideas, stories and friendship.

## Morning Garden Two-Day Transition Structure

This class meets twice a week on *Thursday* and *Friday* mornings from 9am-12:00pm. It will begin as a parent/child class and after 8 weeks will transition into a class just for the children. Children must be 2 years old by June 1 to enroll in this option of the Morning Garden Program. This class meets for 32 weeks, and children are enrolled for the entire program, September through May. Tuition includes a healthy snack and materials. Class size: 10 children maximum.

## Session Dates, Program Fees, & Payment Options

A 32-week program September through May (8 weeks of parent/child and 24 weeks of child only)

- a. Full amount due September 2 - \$ 2,200.00
- b. Semi-annual: Two payments of \$1,100.00 due Sept. 2 and Jan. 2
- c. Monthly payments: 8 Payments of \$330.00 due the 1<sup>st</sup> of each month beginning September 1 - April 1

*You will be invoiced for the payment option selected.*

*Payment must be received by the dates indicated or a \$25 late fee will apply.*

**Please note: Enrollment in this program is for the entire 32 weeks and no refunds are given for missed classes.**
